Tom ALLEN (HONG KONG)

Allen has risen to become Simpson Marine's Head of Sales for Hong Kong, where he moved in early 2016 to start working for Asia's largest vacht dealer. Born in London, he spent much of his childhood on the coast of Maine on the northeast coast of the US, where he sailed dinghies and small keelboats, having inherited a love of boating from his father. After graduating from university, he held office jobs in various coastal cities around the US, always keeping in touch with the ocean by using days off to enjoy sailing, fishing and powerboating. In Hong Kong, he continues to enjoy spending his weekends on the water, where he explores the territory from corner to corner on his Highfield RIB.



Jesus 'Jun' AVECILLA

Subic Sailing Club (SSC), Avecilla is also a founding member of Ocean Racing Club of the Philippines (ORCP). SSC and ORCP, together with Phinsaf, are the organising authorities of the annual BPI Private Wealth Signature Yacht Race Series comprising of The Corregidor's Cup, The Busuanga Cup, The Boracay 200 and The Subic Bay Regatta. Last February, Avecilla led his Subic Sailing Team as skipper of his Beneteau First 36.7 Selma Star to win the IRC Overall in the popular Boracay 200, ending the year third overall in the BPI Yacht Series. In the 2024-2025 racing season, they took IRC Overall position in the first race of the series,



Mohammed ALSHAALI (UNITED ARAB EMIRATES)

Alshaali is Chairman of Gulf Craft, which he co-founded in 1982 and developed into the Middle East's most prolific yacht builder, producing the Majesty, Nomad, Silvercraft and Oryx brands. A businessman and diplomat with over 35 years of experience in international relations - including serving as the UAE's Ambassador in New York, Washington, Geneva, Canada and Mexico, and as Minister of State for Foreign Affairs - Alshaali retired in 2008 and devoted himself to Gulf Craft, which grew into one of the world's top-15 superyacht builders. At Cannes Yachting Festival 2024, Alshaali unveiled the Majesty 100 Terrace, scheduled to make its world debut at Dubai International Boat Show 2025.



Albert ALTURA (PHILIPPINES)

Chairman and co-founder of the Ocean Racing Club Philippines (ORCP). Altura is also a former US Navy Commander, and aviator. He owns and operates Red Core Geothermal. a renewable energy company, ORCP revived the iconic Boracay regatta, now called BPI Boracay 200, as well as the BPI Corregidor Cup which makes up part of the BPI Signature Yacht Race Series along with BPI Subic Regatta and BPI Busuanga Cup in Palawan. He has been an offshore sailor since his teens, having participated in the 1986 China Sea Race and in 2018, the Rolex Middle Sea Race. In the 2023 Rolex China Sea Race, his yacht Hurricane Hunter came in fifth overall.



Olivier BESSON (HONG KONG)

Besson is founder and CEO of Asia Yachting, whose portfolio includes Prestige, Fountaine Pajot and Nautique across selected markets in Asia. Highlights in 2024 included the Asia premiere of the Prestige M-Line (M8 and M48 models) at the Hong Kong International Boat Show, private shows at Club Marina Cove and Lantau Yacht Club, and owners' events for Prestige and Nautique owners in Hong Kong. Besson arrived in Hong Kong as an automotive engineer in 2005 and two years later the Frenchman founded Asia Yachting, which also has strong brokerage and yacht-management divisions.



Michael BOGNIER (HONG KONG)

A regular presence at the world's leading boat shows and a rising star in the yachting industry, Bognier is a sales manager at Nextwave Yachting and vacht broker at Northrop & Johnson Asia-Pacific. Nextwave represents multiple prominent brands including Princess, Beneteau, Invictus, Capoforte, Sealine, Fjord, Chris-Craft, Vanguish, and Heyday. With roots in both Hong Kong and Italy, this Eurasian professional has been an avid boater since childhood, making him a hands-on and technically-minded individual. Bognier's international experience includes living in the United States and Switzerland, where he earned a degree in Hospitality Management from Glion Institute of Higher Education.

Asiamarine is also the city's exclusive dealer for Lift eFoils. A Singapore Maritime Academy graduate and skipper (Yachtmaster), Badri has taken quickly to sales, having formerly worked as a Deck Officer then as Aftersales Supervisor for a local yacht dealer.



Nigel BEATTY (JAPAN / MONACO)

Chairman of the Asia Pacific Supervacht Association (APSA), UKborn Beatty expanded his portfolio in 2022 by establishing SYL Monaco and Azure Monaco. Formerly Royal Navy and a supervacht captain, he came ashore in 2004 to establish the SYL Group (Super Yacht Logistics) with SYL Florida, SYL Japan and SYL Australia. Several other companies followed such as Fathom Supply, YOTFIX and Azure Yacht Crew Health, all of which are still successfully operating. Alister BRUNSKILL (SINGAPORE)

Boat Lagoon Yachting's Country Head for Singapore had a successful 2024, securing another new Princess Y85 scheduled to arrive in early 2025. Singapore now boasts five Princess Y85 models and a total of 11 Princess supervachts larger than 24m. With over 30 years of experience living in Southeast Asia, Brunskill previously worked in the UK as the International Sales Manager for the Americas and APAC region at the Princess Yachts shipyard for six years. He has been a Brokerage Representative for Burgess since April 2019.



Peter CAPOTOSTO (PHILIPPINES)

Having been Principal Race Officer for the South East Asian Games in 1991, Capotosto returned to Subic Bay in December 2019 as Assistant Race Officer for the 30th SEA Games. It was another sailing highlight for Capotosto, who was an on-water advisor at the 1988 America's Cup in San Diego. In the Philippines he has been Commodore of Taal Lake Yacht Club since 1996, Director of Philippine Inter-island Sailing Foundation (Phinsaf, 2003-2015), Commodore of Manila Yacht Club (2000-2001), and a multiple winner of the Hobie 16 National Championship.



Maria CARILLO (HONG KONG)

In almost 35 years at Club Marina Cove, Carillo has helped organise 25 editions of the Hong Kong International Boat Show, following the event's return at the end of 2023 after a six-year break. Carillo has long been the hands-on driving force of Marina Cove, which frequently hosts private shows organised by individual dealers and brands. As Assistant General Manager, she manages the clubhouse and the marina, responsible for all aspects of in-water and on-land matters. Carillo joined the Sai Kung marina in 1990, having previously worked in the hotel industry.



Victor CHA (HONG KONG)

Chairman of HKR International, Cha is the mastermind behind the refurbishment of Lantau Yacht Club (LYC) in Discovery Bay, Hong Kong's first 5 Gold Anchor facility and only custom-built marina with berths tailormade for supervachts. Last October, Cha was among VIPs attending the opening ceremony of the second Lantau Yacht Club Boat Show – Festa Nautica. A yachting enthusiast, Cha has a vision to promote yachting in Hong Kong and strengthen the city's position as Asia's hub for the leisure boating industry. As a lifestyle curator, Cha and his team have a proven track record of leading premium property developments and lifestyle projects.



Jeffrey CHAN (HONG KONG)

Chan is a notable figure at the world's premier boat shows and currently serves as the Director of Sales at NextWave Yachting. The company's portfolio expanded last year to include prestigious brands like Princess Yachts, Beneteau motorboats, and Excess Catamarans. Following the acquisition of Thailand's Lee Marine in 2023, NextWave now holds the licence for Northrop & Johnson in Asia. With a robust background in finance and investment, Chan's previous experience includes roles at AXA and Standard Chartered before he joined NextWave in 2012. Beyond his professional achievements, Chan is a lifelong watersports enthusiast and an experienced JetSurf racer.



Vivian CHAN (HONG KONG)

Director of VP Yachts, which she founded in 2020, Chan continues to expand the company's portfolio, which includes Pearl, Dufour, Sessa and Pyxis, plus Awake electric surfboards and eFoils. Late last year, VP Yachts showed three vachts at the Hong Kong International Boat Show, exhibiting a Dufour 41, Leopard 46 and Sessa F47. Chan is a regular international boatshow traveller – the past two years have included trips to Dusseldorf, Singapore, Shanghai, Cannes, Genoa and Amsterdam, for METS. Chan is also General Manager of her family's Sun Hing Shipyard service facility, founded by her father Chan Ki in 1981 and has served as Dufour's North Asia service centre since 2020.



Tony CHEN (TAIWAN)

Simpson Marine's Taiwan Sales Manager, Chen's lifelong connection to the sea began with designing and building his first sailing boat at age 12 in the Penghu Islands. An accomplished windsurfer and vachtsman, he has competed in the Taiwan Strait Race and Penghu Regatta Week. As the Keelboat Chief Executive of Penghu County Sailing Association and a member of the Chinese Taipei Sailing Association, Chen actively promotes sailing activities in Taiwan. In recent years, Chen has been instrumental in introducing luxury and larger vachts to the Taiwan market, with two notable Sanlorenzo models and one Bluegame introduced to the market in the past year.



Kit CHOTITHAMAPORN (THAILAND)

Kit is Asia Regional Manager for Leopard Catamarans and is planning a strong presence at the third Singapore Yachting Festival with the Asia launch of the brand new Leopard 46 sailing cat and the entire Leopard Powercat range. Late last year, the Phuket native also displayed the Leopard 46 power cat at the Hong Kong International Boat Show. In addition, Kit also handles all Asia brokerage yacht sales for sister brands Sunsail and The Moorings, which form the world's largest charter company. Having developed his love for the sea and boats at a young age through his father, a keen recreational fisherman, he began his yachting career in 2003.



Lawrence CHOW (HONG KONG)

Chow has been Chairman of the Hong Kong Boating Industry Association (HKBIA) since 2019 and is Chair of the ICOMIA Asia Working Group, which he helped set up in 2022 to promote and grow boating in Asia. He was also Asia Representative of the ICOMIA Executive Committee from 2020-2023, HKBIA activity includes regular meetings and discussions with the Government, while last year it supported the Hong Kong International Boat Show, where Chow spoke at the HKBIA cocktail evening. Raised in a marine industry family, he is Manager of China Pacific Marine, which represents Jeanneau, Honda, Yanmar, Zodiac Milpro, Boston Whaler and Sunstream in Hong Kong and Macau.



Julian CHANG (SINGAPORE)

Chang is a Board Director of The International SeaKeepers Society and President of its Asia chapter, SeaKeepers Asia. Last year's annual dinner celebrated SeaKeepers' 26th anniversary. He is the founder of The Ocean Collective Summit (TOCS), which held its third Summit at the Sheraton Tower Hotel last year in collaboration with Fabien Cousteau. The fourth TOCS will be on October 16 and 17, 2025. Chang has a share of the 39m Star of the Sea yacht and the 68ft M/Y Legend. He dedicates a portion of charter fees to SeaKeepers Asia for children's education in marine conservation. He is a Senior Advisor for Burgess in Asia, and MD of Raffles Yacht Group, which has representation in 18 offices worldwide.



Frankie CHAU (HONG KONG)

Chau is the Chairman and cofounder of NextWave Yachting, driving forward the success of NextWave, Lee Marine, and Northrop & Johnson Asia Pacific, NextWave represents renowned brands such as Princess, Beneteau, Sealine, Fjord, Chris-Craft, Invictus, Capoforte, Vanguish and Heyday. Chau's passion for the sea began at the age of four, as he spent weekends boating with his parents. At 15, he moved to the United States and later earned a Master's degree in Corporate Finance from Boston University. After returning to Hong Kong, Chau worked as an auditor with Deloitte, bringing a wealth of experience to his current ventures.



Howard CHEN (HONG KONG)

Chen is the CEO and co-founder of NextWave Yachting, established in 2012, and CEO of Northrop & Johnson Asia. In 2024, the company opened a new office in Taiwan, organised The NextWave Beach Music Festival in Discovery Bay and hosted a private vachting event Nexperience 2024 in Hong Kong. NextWave is now a dealer for Princess, Beneteau motorboats, Invictus, Capoforte, Sealine, Fjord, Chris-Craft, Vanquish, and Heyday. The dealership's water toys portfolio includes JetSurf, Lift Foils, iAqua, Belassi, HydroFlyer, Mo-Jet, Manta 5, Aquaglide, Yachtbeach, and JetXTender. Chen, a mechanical engineering graduate from the University of Wisconsin, leads the yacht management and service divisions with teams in Kwun Tong, Sai Kung, and Aberdeen.



Johnny CHUEH (TAIWAÑ)

Chueh is Chairman and CEO of Taiwan's Ocean Alexander, a regular in the top rungs of the Global Order Book for 24m-plus supervachts, ranking 10th in the 2024 edition, having been third in 2023. Based in Kaohsiung with a sister facility in Florida, Ocean Alexander specialises in flybridge and tri-deck motoryachts up to 120ft and its ranges include Revolution (27R, 30R, 35R), Explorer (28E, 32E), Legend (32L, 37L), and now Puro (35P). Chueh has led the company since 2000, succeeding his father Alex who founded it in 1977.



Kevin CORFA (HONG KONG)

Head of Asia for Fountaine Pajot (FP) and Dufour since 2018, Corfa oversaw another busy year for the French sister brands. Highlights of 2024 included the third FP Alegria 67 being delivered in Thailand with The Yacht Sales Co and the local premiere of the FP Aura 51 'Asian special edition', with this specific fly bridge version dedicated to Asian owners' preferences by Speedomarine in Hong Kong. The Dufour 61 flagship has been displayed at various Southeast Asia shows and Corfa recently saw his very first FP MYS.4 38ft power catamarans units arrive in Thailand and Vietnam, bringing a new prospect to the motoryacht markets there.



Antonu COWIE (HONG KONG)

Cowie, founder of boutique law firm, Cowie & Co, provides focused yachting legal advisory services in the Asia-Pacific. A specialist supervacht lawyer of repute, he has gained 20 years' experience working with leading global maritime law firms, and in senior in-house roles with global maritime-sector leaders. Cowie's legal focus in servicing the supervacht sector is regularly involved in significant high-value vacht transactions in the Asia-Pacific and Europe. The firm advises international clients, including owners (buyers or sellers), yacht builders, dealers, brokers, yacht managers, designers and crewing agents, to name some categories. A sailor himself through the Royal Hong Kong Yacht Club, Cowie enjoys recreational sailing at weekends.



Luca CRISTINO (HONG KONG)

After joining Simpson Marine in March 2024 as Executive Chairman, following the company's acquisition by Sanlorenzo, Luca Cristino then took the role of Group CEO some months later and relocated from Italy to Simpson Marine's and now Sanlorenzo's Asia-Pacific base of Hong Kong in early 2025. From Turin, he has been a prominent name in Italian shipbuilding for three decades - most of which was spent with Azimut. He was also Deputy Director of Yachtique, a service division under the Azimut-Benetti Group, and then joined Sanlorenzo in 2018.



Colin DAWSON (HONG KONG)

Based in Hong Kong since 1994, Dawson is a specialist yacht-insurance broker with 30 years' experience in the Asia-Pacific market. Founding Chairman of Asia-Pacific Supervacht Association, he handed over the reins in 2016 and is now a member of Global Marine Business Advisors. In 2009, he set up The George Group, which partners with the global insurance broking house Howden, working closely with its worldwide offices for vacht and high net worth insurance programmes. A passionate conservationist, he set up The Elephant Foundation in 2014, hosts the annual Elephant Week in Hong Kong, and runs the Ŝan Fernando Race Foundation for underprivileged children in the Philippines.



Olivier DECAMPS (HONG KONG)

With more than 45 years spent in the yachting industry, Decamps has been in Asia for over 20 years and Nautor Swan APAC Regional Director since 2017 selling yachts from India to Japan and Australia/New Zealand, His appointments have included Simpson Marine. The Belgian studied Yacht Design and Yacht Building Technology, and he worked for Camper & Nicholsons in the UK as well as Wauquiez and Beneteau Groupe in Europe. Decamps has sailed over 300,000nm, made multiple ocean crossings cruising, and raced in several Rolex Sydney Hobart, Rolex Fastnet and Rolex Giraglia races, among others.



Adam ESSEX (HONG KONG)

Boasting three decades of experience in the luxury yachting sector, Essex has overseen Princess activity in the region for five years, having been General Manager for Asia Pacific since early 2019 then Regional Director for Asia Pacific and Middle East from 2022. He has been based in Asia since 2014, working for the Princess Yachts South East Asia dealership in Thailand and later moving to Hong Kong before joining the shipyard. Earlier roles included retail sales for his own independent brokerage company and as a senior broker at UK-based distributor Princess Motor Yacht Sales.



Scott FINSTEN (THAILAND)

Harbour Master of Ocean Marina Jomtien, Finsten has overseen its development as it has grown into Southeast Asia's largest marina complex. The heart of boating in the Gulf of Thailand, the complex now features over 450 berths accommodating vessels up to 75m, state-of-the-art 25-tonne and 75-tonne Travelifts, and over 50 diverse tenants. Finsten organises quarterly Grow Boating Pattaya industry gatherings, monthly races, and events including overnight sailing excursions to picturesque islands off the coast of Pattaya. Finsten brings a wealth of knowledge from his tenure at the Cruising Yacht Club of Australia, renowned as the host and organiser of the Rolex Sydney Hobart Yacht Race.



Paul GRANGE (HONG KONG/SINGAPORE)

With business partner Thomas Woo, Grange is the co-founder of Marine Italia (2015), the largest Azimut Yachts Dealership in APAC, representing Azimut in Hong Kong, China, Macau, Taiwan and Singapore, Sales in 2024 include a Magellano 30 and the first hull of the new Grande 30M for Hong Kong and a Grande 36M to Guangdong, China, the largest Azimut ever sold in China, both for delivery after their Cannes debut in 2025. Since 2024 the company also represents Aguila Yachts in Hong Kong and Singapore. Grange splits his time between Hong Kong and Singapore, has worked in international yacht sales for over three decades and initially moved to Hong Kong to work as Head of Azimut for Simpson Marine (2012-2015).



Dai Tu DOAN VIET (VIETNAM)

Founder-CEO of Tam Son Yachting in Ho Chi Minh City, one of the country's leading yacht dealers, has represented Beneteau and Lagoon from 2017, Azimut from late 2020 and Saxdor from 2021. It opened Vietnam's first yacht service centre in 2018, provides yacht management, crew and charter, and runs Vinhomes Central Park Marina and Tam Son Yacht Club at Swan Bay. Recent sales include a 70ft Azimut S7, an Azimut Grande 25: a Grande 27 is set for delivery in late 2025. The first ever semi-custom Grande 32 was just delivered, soon to become Vietnam's first superyacht charter at Tam Son Yachting's new Halong Bay branch.



Ernesto 'JUDES' ECHAUZ (PHILIPPINES)

In preparation for the 2025 South East Asian (SEA) Games, Echauz has purchased Optimists, ILCAs, 420s and 470s for the Philippine Sailing Association (PSA). His all-Filipino team joined the Rolex Sydney Hobart Race 2024 with Centennial 7, a Judel-Vrolijkdesigned TP52 which won IRC Overall the same race in 2022. He won 2023 Rolex China Sea Race line honours and IRC 0 on his Reichel/Pugh 75 Standard Insurance Centennial 5. His TP52 won the 2017 San Fernando Race and topped its IRC class in two China Cups and the 2018 Rolex CSR. Group Chairman of Standard Insurance and former President of the PSA. Echauz often sponsors national teams and sailing events, buying 10 FarEast 28Rs that helped win five golds at the 2019 SEA Games.



Mark ELKINGTON (AUSTRALASIA)

Long a sales rep and consultant for French vards Fountaine Pajot and Dufour, Elkington rode the interest in sail and power multihull vachts, establishing Multihull Solutions in Australia and New Zealand, then in the Pacific and Southeast Asia, based initially in Singapore and Phuket. He launched ILIAD powercats, built at two locations in China. Multihull Solutions re-branded as The Yacht Sales Company, taking on agencies for other monohulls, now representing Absolute, Tesoro, Maritimo and Gulf Craft, among other yards. In January 2025 it was announced that Fountaine Pajot had taken a 60 per cent equity in TYSC, the 15-office sales group, although Elkington commented that it will be "business as usual".



Philippe GUENAT (THAILAND)

Guenat is the owner of PMG Shipyard. where yacht production includes the Cora Cat 48 represented by Multihull Solutions, the Solar Explorer 52 with e-propulsion and the Silent 60/62 solarpowered catamarans. The shipyard evolved from the former Bakri Cono yard at Ocean Marina, where the Swiss national developed his plans for a solarassisted powercat by launching the Heliotrope 65 in 2013. Increasing his involvement with the builder, Guenat sourced the current 20,000sqm seaside location in Rayong, where operations began in 2016 and the shipyard was renamed PMG in 2019.



Erwan HER (HONG KONG)

Since joining Beneteau in Hong Kong in 2016, Erwan was promoted to Asia-Pacific Sales Director and Group Office Manager in 2021. His notable achievements last vear included organising events to celebrate the brand's 140th anniversary across the APAC region, from Japan to Tahiti. He also led a comprehensive restructuring of dealerships in Asia, appointing NextWave and Asiamarine in Hong Kong and Singapore, Primus Marine in Thailand, and Amal Yachting in Taiwan. A graduate of the Nautical Institute of Brittany, Erwan previously spent five years with The Moorings and Sunsail in Turkey and nearly two years with Simpson Marine in Hainan and Hong Kong before joining Groupe Beneteau.



Edwin HO (HONG KONG)

Ho is the founder and President of Starship Yachts, which celebrated its 30th anniversary in 2024 and is Ferretti Group's long-time dealer in Hong Kong and Macau. Last year's highlights included the sale of hull number one of the all-electric Riva El Iseo, as well as the first hull of the Riva 33 Aquariva Special – both arriving in Hong Kong in 2025; Ferretti Yachts 500 and 720 were also sold. A Wally Tender 43X - the first unit with outboards – just arrived in Hong Kong; and two sales of the Riva 102' Corsaro Super are set to arrive this year. Ho is also Burgess' Chief Representative for Hong Kong and Macau.



Tommy HO (HONG KONG)

Boasting over two decades of experience in yacht insurance for high-net-worth clients, Ho is founder and CEO of Voyager Risk Solutions, a specialist in luxury yacht, private client and corporate insurance solutions. He also provides vacht investment through Beagle Asset Management and represents Electrine electric and hybrid propulsion systems. A long-time boat owner and Royal Hong Kong Yacht Club member, the entrepreneur continues to help develop various sectors of the vacht industry including repair and maintenance, as well as support Hong Kong Sea School graduates, and is Chairman of both Hong Kong International Chamber of Maritime Economy and the new GBA Hong Kong Yacht Association.



Martin HOLMES (THAILAND)

Holmes is a senior broker at Lee Marine and Northrop & Johnson Asia Pacific, possessing extensive knowledge and experience in vacht management, new construction, insurance, legal matters, marketing, and finance. He has worked with prestigious brands such as Ferretti Yachts, Pershing, Custom Line, Riva, and Jeanneau. A lifelong boating enthusiast, Holmes achieved his RYA Yachtmaster Offshore and embarked on a professional vachting career. His roles have included Yachting Instructor and Flotilla Captain for Sunsail in Greece and Turkey, where he imparted his skills and passion for sailing to others.



Gordon HUI (HONG KONG)

Working with Starship Yachts on Ferretti Group sales, including models by Riva, Wally, Pershing, Custom Line and Ferretti Yachts, since the end of 2024 after spending three years with Camper & Nicholsons, Hui has extensive experience of selling vachts and supervachts in Hong Kong and across Asia. After schooling in the UK, he studied architecture in London, and then spent his early career in the property industry in the country, where in 1992 he bought the first of seven Sunseeker vachts he would own over the next 25 years. He finished 29th in the IMOCA class in the 2022 Route du Rhum transatlantic race.
